I have the honour to request that sanction may be accorded for the purchase of a card trimmer for use in the library at a cost of Rs. 125. The instrument purchased under sanction in G.O. No. 887 Home (Education) dated the 7th August 1920 is very much in use in the Museum Press for trimming museum labels, photographs etc; and it has been found difficult to spare it for library work. Moreover library work demands a much stronger one for cutting straw boards for the preservation of

our large accumulation of unbound periodicals. I understand that an instrument of the required strength is not available in Madras but the Photo Emporium has promised to get one for me from outside for the cost mentioned above. The cost will be met from the grant under Non Contract Contingencies - Voted - Miscellaneous - Library contingencies."
