I have the honour to state that the Council in their
Resolution No.400 dated 20-12-24 sanctioned an advance of a month's

lence of plague in the town, and the same has been recovered in 6
monthly instalments agreeably to the instructions laid down in G.O
No.188 Routine, Law, (Education) Department dated 16--4--24. The
District Inspector of Local Fund Accounts has raised the objection
that the sanction of Government is necessary for this act of the -
Council. I doubt, however, if sanction is necessary in a matter
like this, but if Government considers that such sanction is neces-
sary, I request the Government will be pleased to accord the --
necessary sanction.
