Sir,

I have the honour to state that the President, District Board, Saidapet reports that the weaving class sanctioned in the Board High School, Poonamalle has been steadily doing good work since 1st October 1924, on which date alone actual weaving was commenced and requests that the class be continued during the current year, and that a subsidy of Rs.221 be sanctioned towards its maintenance during the year 1925- 26.

2. The Adviser to Government on Manual and Vocational Training who inspected the class on 22-7-25 reports that 120 pupils of Forms II to V are receiving instruction in weaving. He estimates the recurring expenses
