East Godavari passed at its meeting held at Cocanada on the 25th
July 1925. 3

XIX. Read letter No. nil dated 26-6-1925 from M.R. Ry D.V.S. Prakasarao
garu, B.A., stating that in a Government order published in the
Fort Saint George Gazette dated 23-6-1925 it is laid down that
half fee concession in Secondary schools and colleges to pupils
of (backward) and depressed classes should not be denied to them
because of their conversion to Christianity, that there are still
elementary schools in this District and elsewhere where primary
education has not been declared free and that therefore the --
above concession should also be extended to converts and their
children reading in elementary schools and that to make matters
clear the list of Backward and Depressed classes of the district
should be so revised that it includes the caste Hindus and the
Christian converts of each class and requesting that this sub-
-ject may be placed before the Council so that the Government
may be addressed with the support of its resolution for the issue
of an order in the manner suggested.

The instructions of the Government will be solicited with re-
gard to the extension of the concession in the notification to
the children of Christian converts from backward classes and
those that are Christians themselves reading in elementary ---
schools.

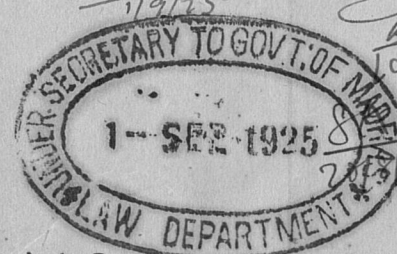

Fee concessions to Indian Christian pupils of
depressed classes origin in elementary schools -

The decision as to which classes should be con-
sidered as backward for purposes of elementary educa-
tion rests with District Educational Councils.
Rule 73 (1) of the Madras Educational Rules provides
for the admission in elementary schools under public
management of pupils belonging to the depressed classes
and to the classes and castes declared to be backward
without payment of fees. On the analogy of the orders
issued in G.O.No. 855 Law (Education), dated 19-5-1925,
in respect of secondary ~~and~~ schools and colleges, there
is no objection to declaring that pupils of depressed
classes will not forfeit their eligibility for admis-
sion without payment of fees after their conversion to
Christianity.
