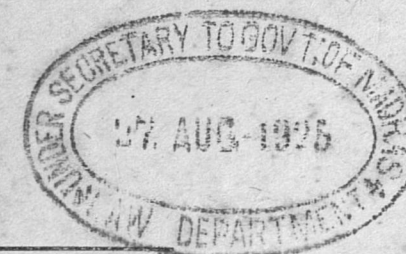

In inviting the attention of Government to the penultimate para of my letter R.C.No. 869 A/23, dated 15th July 1925 stating that the Principal, Government College, Coimbatore has reported that the supply of the newspaper "Daily Express" has been stopped, I have the honour to state that the Principal now reports that the college was in receipt of the daily till the end of 1924 and that subscription was paid in advance out of College contingencies for that period. 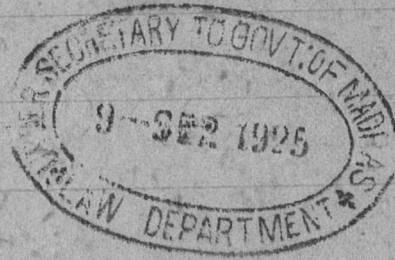
