I have the honour to submit the enclosed application for grant-in-aid towards the purchase of articles of science equipment at an estimated cost of Rs.6877/- and of books etc., at an estimated cost of Rs.3404/- only required for the American College, Madura, and to request that you will be so good as to obtain the sanction of Government for its inclusion in the approved list, rendering the institution eligible for a grant of two thirds of the cost not exceeding Rs.4585 towards the purchase of science articles and a grant of one half of the cost not exceeding Rs.1702 towards the purchase of books etc., if and when

funds become available provided that all the conditions of the grant-in-aid code are fully complied with.

2. The estimated cost of the books has been reduced by Rs.22-8-0 being the cost of items 148 'F' and 148 'L' in the list of Natural Science books not recommended by the Principal of the Presidency College, Madras, as being above the standard of the Intermediate classes.

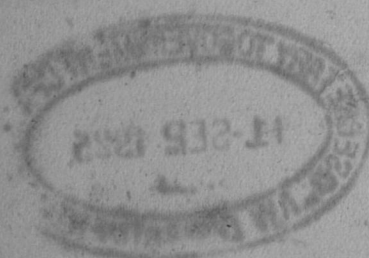
