Kanda Sivar-amayyo, the boy's father, lives at Jagulupeta hamlet of Andhavaram village, thana Chicacole, in the district of Ganjam. A copy of the boy's detention warrant is enclosed.

In the court of D.G.Davies Esqr., Additional District
Magistrate, Midnapur.

Whereas Appa Rao son of Sew Ramayo, resident of village
Jugalpetta, thana Chikakole, district Ganjam, Madras Presidency
has, on the 20th day of February 1925 been convicted by me
at Midnapur of the offence of theft Sec.379 I.P.C. and has
been sentenced to imprisonment for three (3) months, which
sentence he is now undergoing in the Jail at Midnapur.

And whereas the said Appa Rao ^{is} under the age of fifteen
years and is a proper person to be an inmate of a Reformatory
school:

It is therefore ordered that, instead of undergoing
his sentence he ~~is~~ be detained for a period of Five (5) years
in the Reformatory School at Hazaribagh.
