Report on the audit of the Elementary Education Fund Account of the Srirangam Municipality, Trichinopoly district, by Mr.J.M. Hooper, Examiner of Local Fund Accounts, for the period extending from 1st April 1924 to 31st March 1925.

The audit for the periods noted below was conducted by District Inspectors Messrs.G.Venkataraya Pai and T.V.Ramaswami Ayyangar in accordance with the rules on the subject:--

January 1925 to March 1925	11-5-1925	2- 6-1925.

2. During the period under audit, the office of Chairman was held by M.R.Ry.K.Chinnaswami Odayar Avargal from 1st April 1924 to 31st October 1924, by M.R.Ry.R.V.Palniswami Pillai Avargal from 1st November 1924 to 7th November 1924 and by M.R.Ry.K.Singam Ayyangar Avargal from 8th November 1924 to 31st March 1925.

3. A statement of receipts and charges is appended.

4. A note on the defects found in the accounts has been forwarded to the Chairman, Municipal Council, Srirangam. The general result is satisfactory.

5. Amount of contribution not fully made. The amount actually contributed from the General funds of the Municipality was Rs.4,360-5-10 against a provision of Rs.4,502 in the revised estimate for 1924-25. The balance should be adjusted at an early date.
