Sir,

The authorities of the Ramakrishna Residential High school, Mylapore request that the vacant plot of ground bearing R.S. No. 1605/5 lying to the South of the school building may be acquired under the Land Acquisition Act and that a half grant on the total cost of acquisition may also be sanctioned.

2. A site plan showing the position of the school and the land proposed for acquisition is herein enclosed. The reasons adduced for the acquisition are :-

(1) The landlord proposes to sell it piece-meal to a number of people as house sites. The houses that may be constructed will face south, presenting their backyards and latrines to the school

and will also block the free flow of the South wind;
(2) a plot of ground very near the school is quite necessary for the construction of masters' quarters. The site under reference is the most suitable to meet the demand. If it is acquired the quarters may be constructed on the western half leaving the eastern half open for the free perflation of the South wind.

3. The Collector of Madras has valued the site at Rs. 28,529-15-6 (vide valuation statement enclosed) and the Correspondent of the school reports that the landlord refuses an answer to his requests for its purchase by private negotiation.

4. In the circumstances set forth above, I have the honour to recommend that the site in question may be acquired under the Land Acquisition Act and that the scheme may be placed in the list of approved works at a cost of Rs. 28,530/-

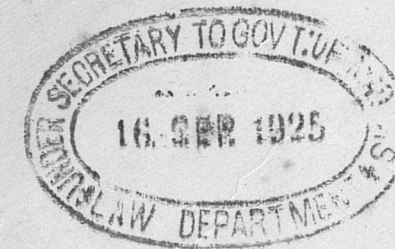

Whereas it appears to ^{the} Government that the land specified in the schedule below and situated in Mylapore Division, Madras Taluk, Madras District ~~are~~ needed for a public purpose to wit for the construction of ~~Masters~~ ^{the} quarters for Ramakrishna Residential High School, ~~notice~~ ^{Mylapore} to that affect is hereby given to all whom it may concern in accordance with the provisions of section 4(1) of the Land Acquisition Act I of 1894 as amended by the Land Acquisition Amendment Act XXXVIII of 1923. The Government hereby authorise the Collector of Madras and his subordinates to exercise the powers conferred by section 4(2) of the Act ^{(3(c) and 5A)} under sections ~~3~~ appoint the Collector of Madras to perform the functions of a Collector under ~~section 5-A~~ of the Act. All persons interested in the lands are required to lodge before the Collector of Madras within 30 days after the publication of this notification a statement in writing of their objections if any to the proposed acquisition.
