Sir,

I am directed to convey the sanction of the Government of India to the officiating appointments mentioned in the two statements forwarded with your letter No. 1882, dated the 2nd December 1924, which have been made in the Indian Educational Service for periods exceeding six months. The Secretary of State in Council will be asked in due course to confirm this sanction in respect of those officers whose officiating appointments have extended or will extend over two years.

2. The Government of India also agree to the officers noted in paragraph 2 of your letter continuing to officiate in the Indian Educational Service until they are relieved by other officers of that service returning from leave or till the recommendations of the Lee Commission are given effect to, whichever is earlier.
