Madam,

With reference to your endorsement R.O.C.No.
38-N/25 dated 6-8-1925 I have the honour to state that
the aided elementary Girls' schools in the Nilgiri
District are not generally inspected by the Deputy Ins-
pector of schools, Nilgiris Range, Ootacamund.

And as such, I do not think that the Deputy
Inspector will be in a position to grant the certificate
as required in Rule 2(ii) of the Rules framed and -
approved by the Council for the payment of Teaching
Grants in instalments to aided elementary schools.

As the Annual inspection of Elementary Girls'
schools for grants is done by the Assistant Inspectress
of schools, I request that you will be good enough to
address the President, District Educational Council to
the effect that the following addition to Rule 2(ii)
of the Rules in question may kindly be made.

Rule 2(ii) "Grants in instalments shall be paid
to such schools as are certified by the Deputy Inspector
of schools in the case of schools for boys and by the
Assistant Inspectress of schools, Coimbatore Girls'
Range in the case of institutions for Girls' " etc.,
etc.
