Mr.Krishnamarazu's work in malarial tracts has at last affected his health. I am sending him this year to continue the survey of the agency boundary of Godavari - District but it is doubtful if he will be able to do this kind of work much longer and I wish to have another man

of the same stamp given a substantive appointment.

This is K.N.Achutan, a deputy surveyor. He has passed all the departmental tests and in 1923 was awarded the gold medal for getting the highest marks in the Head Surveyor and Sub Assistant's test, in competition against several Probationary Head Surveyors who had graduated in Mathematics.

2. Since April 1924, he has been making theodolite surveys in the foothills of the Western Ghats under the supervision of the Logging Engineer, Forest Department, who is most appreciative of his work. | p 3 mpa

I request the Board will be pleased to recommend that he be exempted permanently from the provisions of Article I of the - Public Service Notification so that he may be confirmed in the grade of Head Surveyor and later in that of Sub Assistant, should his work continue satisfactory.
