Sir,

I have the honour to submit below a scheme for the introduction of weaving in the Government Muhammadan training school, Arcot.

2. Instruction is proposed to be given to about 56 students under training who will be divided into 5 sections for purposes of instruction and each section will receive one half day's instruction per week.

3. As regards the additional accommodation required for the weaving class it has been reported that the existing ryots shed in the school can, with suitable alterations, be used for the purpose. The cost of repairs and improvements to the shed is estimated at
