Sir,

In submitting herewith a copy of letter R.C. G.O. No.9-T.B./25 dated 1-8-1925 from the President, Taluk Board, Ialgudi, I have the honour to state that the Examiner of Local Fund Accounts reports that the amount actually realised from the levy of Education cess during 1923-24 and credited to the Elementary Education Fund under the control of the Taluk Board was Rs.8625-12-0. (Please see copy of his letter enclosed) But the subsidy actually paid under section 37 of the Madras Elementary Education Act in G.Os. Nos.653 Law (Education) dated 29-4-1924 and 309 Mis.,

Law (Education) dated 3-3-1925 was Rs.8344-9-0. Taking the Examiner's figure, an arrear subsidy of Rs.281-3-0 is payable to the Taluk Board. I recommend that this amount may be paid to the Taluk Board.

2. The expenditure may be met from the provision of Rs.37,02,300 made in the ^{civil} original budget estimate for 1925-26 under "31 C(c) Education - Primary - Grants to local bodies for primary Education - Grants-in-Aid-Education-Non-Voted-recurring - Grants under section 37 and the proviso to section of the Madras Elementary Education Act".

Copy of letter R.O.G.O. No.9 T.B. of 1925, dated 1st August 1925 from the President, Taluk Board, Ialgudi, to the Director of Public Instruction, Madras.

Subject:- Elementary Education - Ialgudi Taluk Board - Balance of contribution under section 37 of the Act - 1923-24 adjustment requested.

I have the honour to state that a sum of Rs.34503 had been actually credited to this Taluk Board under land-cess for the year 1923-24, of which Rs.8626/- relates to Education Tax i.e., $\frac{1}{4}$ of the land-cess income. This sum had been credited to Elementary Education fund as may be seen from the Comparative Annual Account of this Board for 1923-24. But an equivalent Government grant of Rs.8,344-9-0 only has been adjusted to this Taluk Board for the year 1924-25 as per G.O. No.653 Law (Education) dated 29-4-1924 and 309 Mis., dated 3-3-1925. Thus there is a difference of Rs.281-7-0. I therefore request that you will be so good as to move the Government for

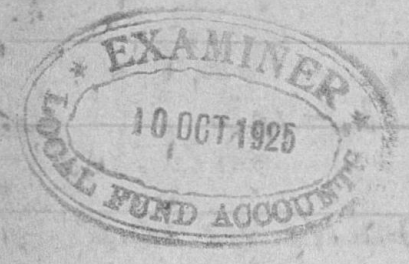

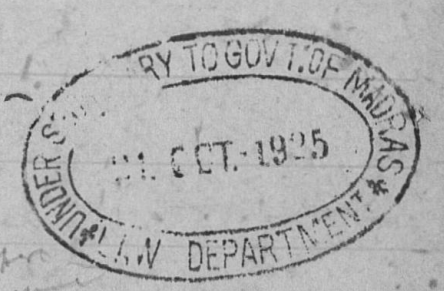
