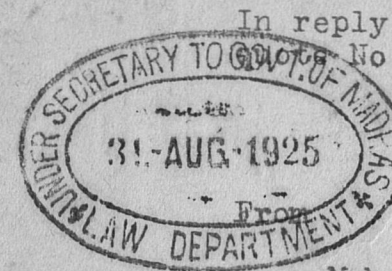

request that necessary orders may therefore be issued under
section 10 (b) of the Madras Elementary Education Act of 1920.

in the Taluk Board, Sivaganga, yet holds office of the member-
ship on this Council for a period of three years from 18-12-23
the date of publication of his name in the Fort St. George --
Gazette as per G.O.No.543, Law (Edn) dated 4--5--1922.

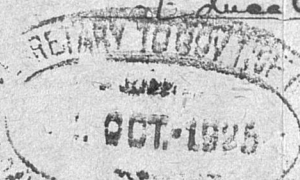
