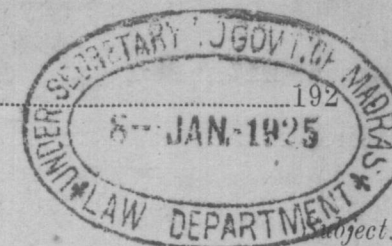

was issued prior to the clubbing of the offices of the
District Educational Councils, Malabar, Nilgiris, and
Vizagapatam with the offices of the respective District
Educational Officers. Since the clubbing of these
officers under G.O. No. 1024 Law (Edn) dated 24-7-23,
and G.O.No. 1027 Law (Edn) dated 24-7-23, grants to meet

The Superintendent of Stationery was informed
that the cost of stationery hitherto paid for by the
District Educational Councils was met from the allotment
placed by Government at their disposal and that in the
case of the District Educational Councils, Vizagapatam
and Malabar and the Nilgiris, Government have discontinued
the allotment on the understanding that the stationery
required for the work of these District Educational
Councils would be provided for by the departmental offices
in which the offices of the District Educational Councils
were merged. He was also requested to provide the District
Educational Officers, Vizagapatam and Malabar and the
Dy. Inspector of Schools, Nilgiris with the necessary
additional ^{Stationery} supply required. The Superintendent of Stationery
has however replied to the effect that sanction of Government
is necessary for the additional supply.

In these circumstances I have the honour to
request that Government may be pleased to direct the
Superintendent of Stationery to supply the officers in
question with the additional stationery required by them
on account of the work of the District Educational
Councils done in their offices.

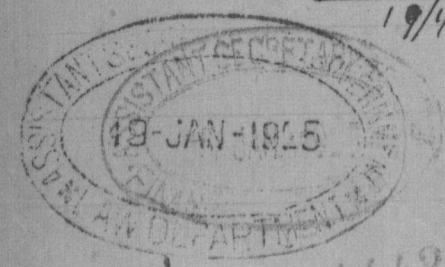
