Sir,

In G.O.No. 1549 Law (Education) dated 4th September 1925 sanction was accorded to the creation for a period of two months of a temporary post of Special Officer in my office for conducting a survey of Secondary Education in the Presidency and Mr. R.M. Statham was appointed to the temporary post.

The Special Officer, since he joined duty in my office on 15-9-1925, has been required to work at the Secretariat or Legislative Council, in connection with the Andhra University Bill, for as many as 10 days and he is further likely to be required to be present at the Secretariat during the Sessions of the Legislative Council which will begin on 28th October.

The work assigned to the Special officer is in any case of such a nature that it could not be completed in two months. Facts and statistics have to be collected and only after that work has been done can deductions and suggestions be made. In addition the revision of the present system of subsidies and the revision of the grant-in-aid Code must necessarily take a considerable time.

Moreover, the Special Officer has been suggested as the Secretary of the Committee to be appointed in connection with the reorganization of Secondary Education. It will be impracticable for the Committee to finish its work by November 14th and the Special Officer will be needed for the meetings of the Committee and for the writing of the report. His period of special duty will thus necessarily have to be extended.

In these circumstances, I have the honour to request that Government will be pleased to sanction the retention of the Special Officer and his establishment till December 31, 1925.

I submit herewith a reappropriation statement providing the necessary funds to meet the salary of the Special officer. No further reappropriation is considered necessary at present to meet the cost of continuing the establishment sanctioned for the Special Officer.

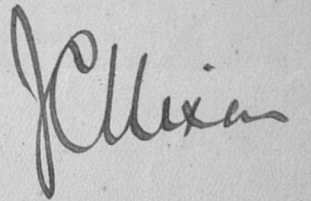

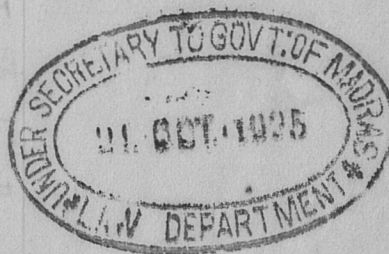
