The credit of Rs. 11,520/- towards Government grant under proviso to section 37 of the Elementary Education Act in the revised estimate for 1924-'25 was with reference to the anticipated collection of arrears of education cess for 1923-24 on which Government grant is due.

I may here state that a sum of Rs.4,049-10-11 under land cess for 1923-24 was adjusted to the credit of the Board on 20-12-1924 and the education cess is pending adjustment. The matter is under correspondence with the Accountant General, Madras. Copy of this office letter dated 8-5-1925 sent to the Accountant General, Madras is also enclosed. Under the circumstances the amount taken credit for under this ~~Head~~ head need not be reduced as ordered.

The expenditure on account of prizes and scholarships

scholarships will be limited with reference to the actuals of 1923-24 as ordered.

Sir,

A sum of Rs. 4049-10-11 being the balance of land cess for 1923-24 due to this Board was adjusted by the Treasury Deputy Collector, Malabar to the credit of this Board on 20-12-1924 on the authority of your A.C. X 697 Mal dated 11-10-1924.

As 25% of the land cess for the year has to be adjusted towards education cess, I wrote the Treasury Deputy Collr. in this office letter R.C.No. 1117/L.F.24 dated 24-12-1924 (copy enclosed) requesting him to adjust Rs. 2024-13-5 towards education cess. The amount was not adjusted by him as requested saying that Rs. 4049-10-11 represents the balance of land cess and education cess together. I doubt if this is correct. I have the honour to request you will be pleased to look into this matter and issue orders to the Treasury Deputy Collector to adjust Rs. 2024-13-5 towards education cess to the accounts of this Board.

In the circumstances stated in the letter from the Examiner of L.F.Accounts read above, the Govt. sanction the payment to the Taluk Board, Ernad, of a sum of Rs 1349-14-0, being the balance of Govt. contribution ^{due} under section 37 of the E.E.Act, 1920, ~~due~~ in respect of the education tax collected in 1923-24.

2. The A.G. is requested to place the amount at the disposal of the taluk board at an early date. The P.T.B., Ernad, should present the necessary bill ~~Bill~~ at the Treasury for obtaining payment or adjustment of the amount sanctioned.

3. The expenditure will be met from the provision of Rs 37,02,300 in the current year's C.B.E. under "31-c-(c) Education - Primary - Grants to local bodies for Primary Education - Grants
