From the Board of Revenue, Land Revenue & Settlement,
Ref.No.B.875/25-2 dated 1st May 1925.

Order:-

The Government direct that the initial pay of the permanent establishments in the Survey department should be fixed following the principles laid down in the case of the settlement department in G.O.No.922, Rev., dated 12th June 1923.

2. The Government do not agree with the proposal of the Director of Survey to give retrospective effect from the 1st March 1921 to the initial pay fixed by him with effect from 1st June 1923 in the case of the ten unpassed clerks of the Survey Department. The clerks should be entitled to their first increment as from date 1st June 1923.

3. The Government direct that the power to sanction permanent exemptions from examination rules in the case of unpassed men of the Survey Department should rest with the Board of Revenue.

4. The Board of Revenue is requested to examine the question of recoveries and submit a report on the subject to Government as to whether any excess amounts drawn by the individuals should be recovered and if so, to submit through the Accountant-General a statement showing the exact amount drawn by each individual and the amount proposed to be recovered and the number of instalments in

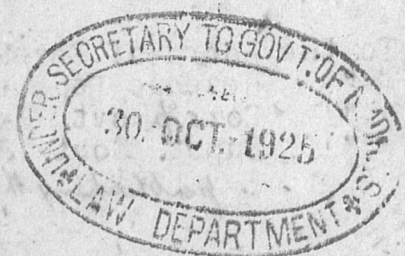
