I have the honour to address Government in regard to writing off the value of a pair of scissors supplied to the Connemara Public Library in 1919. In connection with the replacing of worn out slips for the catalogues kept in the counter for public reference the Sub-Librarian brought to my notice that the scissors supplied to the library was not available. On enquiry I learnt that it was damaged by use and also lost during the days of the previous Sub-Librarian. A new pair has since been obtained from the Stationery Office. The Superintendent of stationery, however, requires for file a copy of the write-off order under Rule 56 of the Stationery Manual.
