The P.T.B. Mannargudi, is ~~in~~ informed that the proceeds of the education tax and the equivalent Earth contribution are intended for the expansion of elementary education and the opening of new elementary schools and should not be diverted to relieve the Board from the expenditure which it has hitherto been incurring on elementary education from its general revenues. The President is requested to report whether the board is willing to contribute a sum not less than Rs. 12,500^(X) from its general revenues to the E.E. fund every year even after the levy of the proposed education tax.
