Report on the audit of the Tinnevely Municipality Elementary Education Fund accounts of the Tinnevely district by Mr.J.M. Hooper, Examiner of Local Fund Accounts, for the period extending from 1st April 1924 to 31st March 1925.

The final audit which commenced on the 6th July 1925 and ended on the 21st July 1925 was conducted by District Inspector, Mr.D.Srinivasa Ayyar, in accordance with the rules on the subject.

2. During the period under audit the office of Chairman was held by M.R.Ry.C.Alagiriswami Nayudu Garu from 1st April 1924 to 31st October 1924 and by M.R.Ry.R.Krishnaswami Rao Avargal from 1st November 1924 to 31st March 1925.

3. A note on the defects found in the accounts has been forwarded to the Chairman, Municipal Council. The general result is satisfactory.

4. A statement of receipts and expenditure is appended.

5. The sanction of Government for the diversion of the Elementary Education Fund called for in paragraph 10 of the Audit Report on the general account of the Municipality for 1923-24 does not appear to have yet been applied for, as ordered in paragraph 5 of Government Order No.1165, Mis. L & M., dated 4th April 1925.

The omission is regretted. The government will be approached now for formal sanction.

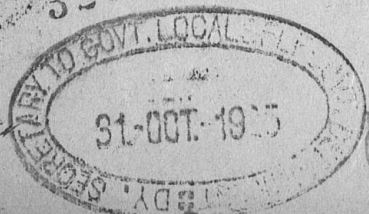

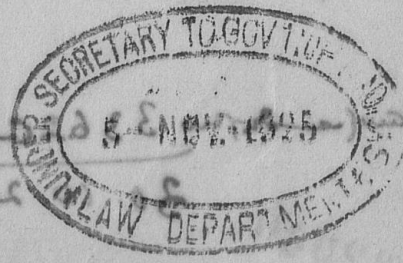
