Report on the audit of the Elementary Education Fund accounts of the Vellore Municipality for the year ending 31st March 1925 by Mr. J. Hooper, Examiner of Local Fund Accounts, Madras.

The audit of the accounts for the period 1st April 1924 to 31st October 1924 was commenced on 6th January 1925 and ended on 26th January 1925 and that for the remaining months of the year under report commenced on 19th June 1925 and ended on 10th July 1925.

2. During the period under audit, the office of Chairman was held by Mr. R. Ry. Rao Bahadur K. Krishnaswami Nayudu Garu, M.L.C.

3. The receipts and expenditure of the municipality during the year under report together with the opening and closing balances, are shown in the abstract of the annual account appended.

4. The opening balance as given in the annual account is in agreement with the closing balance of the previous year's account.

5. The closing balance, viz., Rs. 10,509-3-11, is in agreement with that appearing in the Treasury Pass Book, after allowing for outstanding cheques and for unremitted revenue remaining on hand at the close of the year.

6. The audit was conducted by District Inspector Mr. M. R. Gopal Ayyar in accordance with the rules on the subject. The general result is satisfactory.
