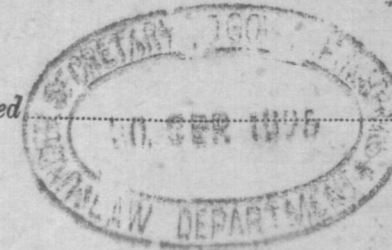

Sir,

I have the honour to invite the favour of your attention to my letter R.O.No.1741-C/24, dated 1-11-1924 disposed of in G.O.No.1938 Law (Education) dated 11-12-1924 and to state that the Government Girls' school at Kumbakonam was taken over by the Municipal Council on 4-6-1924 and that the period of the teacher's service in the school from 4-6-1924 to 30-6-1924, the date on which she was reverted to her permanent appointment, should be considered as duty on foreign service. The Accountant-General reports that contribution

for leave salary and pension for the period has been paid to Government. I recommend that in these circumstances the teacher's services may be considered to have been lent to the Municipal Council for the period.

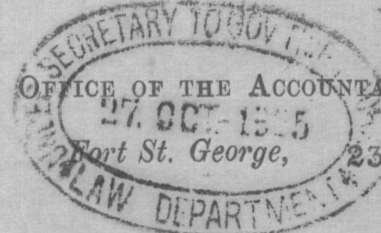

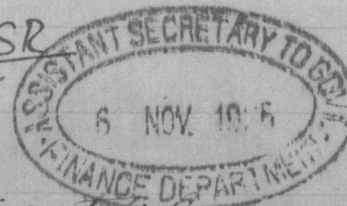

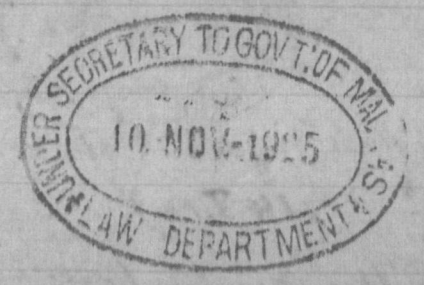
