Sir,

The Government are aware that ever since the constitution of the Madras District Educational Council instead of two permanent clerks on Rs.30/- each a month as sanctioned in G.O.No.516 dated 2nd April 1921 a short-hand Typist-clerk on Rs.50/- is entertained as it is difficult to obtain the services of an efficient clerk on Rs.30 a month with no prospects of promotion or pension. The last order of sanction was accorded in G.O.No.55 dated 12th January 1924 to enure till 31st March 1924. I request that Government would be pleased to sanction the same arrangement till 31st March 1925. The same clerk originally entertained in 1921 continues and if the Government have no objection sanction may be accorded to
