The Govt are pleased to authorize the newly - constituted Taluk boards of Dindigul, Nilakottai and Palni - in the Madurai district to elect two representatives each to the District Educational Council, Madurai. The Taluk Boards are requested to arrange for the election of representatives to the District Educational Council and to report the names in full of the persons elected for publication in the Fort

Accordingly the District Educational Council was constituted and the old Dindigul Taluk Board elected two members viz. M.R.Ry. K.P. Ramaswami Chettiyar Avl., and M.R.Ry. P. Selvamuthu Kavandar Avl., to represent it on the District Educational Council . Vide notification No.151 page 436 of - Part I B of the Fort St George Gazette dated 20-5-24.

Government have in their notification No.1025, published in Part I A of the Fort St. George Gazette, dated 15-9-25, sanctioned , with effect from 1-10-25 the trifurcation of the Old Taluk Board of Dindigul into Dindigul, Nilacottai and Palni Taluk Boards. Members also have been appointed to the new Taluk Boards in Notification No.1022 published in Part I A of the Fort St. George Gazette, dated 15-9-25.

The members already elected by the old Taluk Board of Dindigul to represent it on the District Educational Council have vacated their seats in the old Taluk Board and - they have been appointed as members in the newly constituted Taluk Boards.--M.R.Ry. K.P. Ramaswami Chettiyar Avl., to the Nilacottai Taluk Board and M.R.Ry. P. Selvamuthu Kavandar Avl., to the Palni Taluk Board.

I, therefore, have the honour to request that Government will be pleased to enlighten me as to whether the two members- mentioned above- elected by the old Dindigul - Taluk Board may continue as members of the District Educational Council, Madura or whether they should be considered to have vacated their seats and whether the three newly constituted - Taluk Boards should be requested to elect two members each to to represent them on the District Educational Council.
