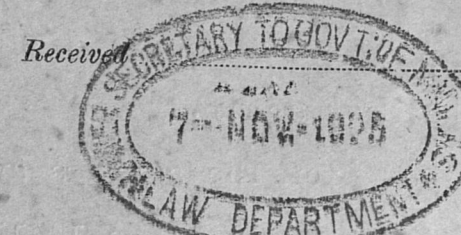

Sir,

I have the honour to state that T.S.Arunachala Ayyar, Headmaster, Government Girls' school, Tiruvendipuram which was transferred to the management of the Taluk Board, Cuddalore under G.O.No.113 Law (Education) dated 23-9-1922, incurred an expenditure of Rs.7/- towards drinking water charges of the school for 3½ months while the school was under departmental control. The Inspectress of Girls' Schools, Central Circle reports that the expenditure incurred by the Headmaster is legitimate and that he is entitled to claim the amount from provincial funds. In these circumstances I recommend that a special subsidy of Rs.7/- may be paid to the Taluk Board, Cuddalore to
