Sir,

With reference to G.O. No.975 Law (Education) dated the 11th June 1925 on the subject of special grants for hostel supervision, I have the honour, by direction of the Syndicate, to forward for the consideration of the Government the following resolution adopted by the Council of Affiliated Colleges at its meeting held on the 15th August 1925.

"That the Syndicate be again requested to address the Local Government pointing out that, with reference to paragraph 3 of G.O., while the managements will be called upon to undertake their share as regards not only rent but also supervision and tutorial work, the grant-in-aid from Government should take into account the expenditure incurred under these both these heads viz., rent and supervision and tutorial work".

I have further to inform the Government that the Syndicate approves in principle the recommendation put forward by the Council of Affiliated Colleges.

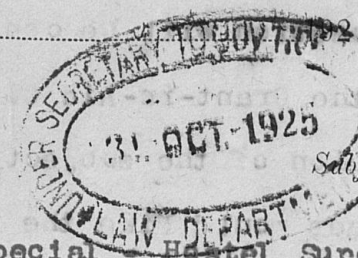

I have the honour to resubmit Government endorsement No.2878 C-1 Law (Education) dated 21-9-1925 with the following remarks:-

As stated by the Registrar of the University of Madras the question was discussed by the Council of Affiliated Colleges at its meeting on 15-8-25. Out of 64 present, 36 voted on the item, 34 being in favour of the Syndicate being asked to address Government and 2 against. The voting did not indicate that the question excited very great interest and no reasons in the course of the debate were adduced, which would have made me consider asking Government to revise their orders conveyed in G.O.No.975 Law (Education) dated 11-6-25.
