Under article 158 of the Civil Account Code, Volume D, the Government sanction the payment of an advance of Rs 150/- (Rupees one hundred and fifty only) to MRRy. C. Mahanty Mahasayo, Deputy Inspector of Schools, Boyzani Range, towards the purchase of a bicycle. The advance which should not be drawn till it is actually required will be recovered in six monthly instalments of Rs 13/- each and six further instalments of Rs 12/- each.
