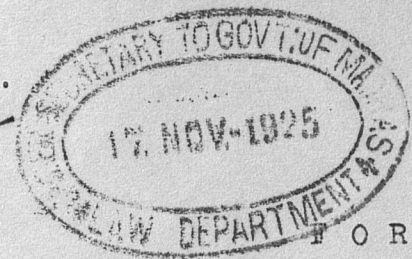

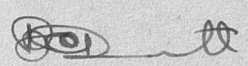

Under article 156 of the Civil Account Code, Vol 2, the Government sanction the payment of an advance of Rs 2500 (Rupees Two thousand five hundred only) to Dr. Chakko, Professor, College of Engineering, Guindy, for the purchase of a motor car.

2. The advance should not be drawn until it is actually required. It will be recovered in 35 monthly instalments of Rs 70/- each and a further instalment of Rs 50/-

$$\begin{array}{r} 35 \times 70 = 2450 \\ 1 \times 50 = 50 \\ \hline 2500 \end{array}$$

3. Interest at 5 per cent a year will be charged on the amount of the advance and will be recovered in accordance with G.O. 624 Finance of 20.8.1924.

4. Dr. Chakko should execute a mortgage bond in the prescribed form. His attention is drawn to the time limit as regards purchase and insurance laid down in Note (3) & article 156 of the Civil Account Code, Vol I. If the amount actually paid for the conveyance be less than Rs 2500, the balance should be refunded to Government without delay.
