Sir,

With reference to G.O.No.1287 dated 24-7-25, Law Education Department reviewing the Budget estimate, Elementary Education Fund of the Sankari Taluk Board for the year 1925-26, I have the honour to state as follows.

Para 1. The Taluk Board in their resolution No.11 dated 12-5-25 sanctioned the levy of Education cess at 3 pies in the rupee and this was approved in G.O.No.1495 dated 27-8-25, and the Collector of Salem in his proceedings R.No.7996-25-C-4 dated 10-10-25 has ordered the collection from the current fasli 1335. A sum of Rs.9,000 has therefore been now provided in the Budget under Education tax receipt side.

Para 2. Credit has been taken for a sum of Rs.1,844 as "appropriation from Government grant-unspent balance for the year 1923-24.

Para 3. The capitation allowance referred to is the payment due for the year.

Para 4. The contribution as fixed by Government from the General revenues has been adopted.

Para 5. The summary referred to is enclosed.
