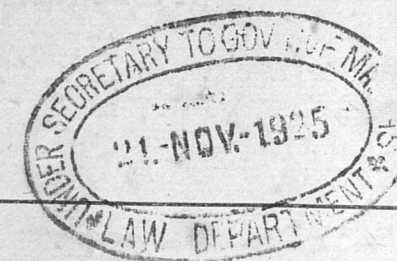

The Electrical Inspector to Government has approved of the Principal's proposals and an estimate for Rs. 384/- has been prepared.
