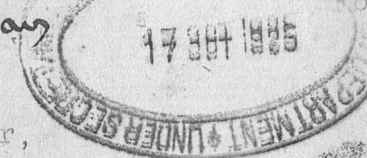

Subject: Somasundaram Pillai - Range clerk -
Coonoor range - Exemption from Examination
Rules.

I request that the Government may be pleased to
sanction the employment of Somasundaram Pillai an unpassed
man as a range clerk on Rs 35-60 in the Coonoor range in
the Nilgiris Dt. in the following circumstances.

2. Somasundaram Pillai was appointed an acting
range clerk in January 1921 and he has been continuously
holding the post since then. The District Forest Officer
who was called on to report why an unpassed man was
appointed and allowed to continue and whether efforts were
made to secure a passed candidate reports that though
of any special attempt to secure a passed candidate, Soma-
sundaram Pillai was the only applicant for the post at the
time. Somasundaram Pillai's work throughout the period of his
employment is reported to have been most satisfactory. The
District Forest Officers may have been at fault in having
allowed him to continue in service so long without taking
steps to replace him but he cannot I think now be replaced
without unfairness. I have no power to exempt him from the
general educational qualifications as I cannot furnish the

Law (Educational) dated 13-6-22 in the circumstances
stated.
