Read: Letter from the Conservator of Forests, II Circle, Bellary, M.2.No. 1208-25 dated 8-11-25.

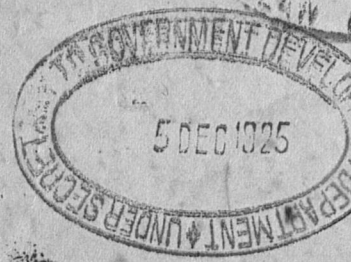
I forward herewith an application from H. Rama Rao present temporary clerk of my office for confirmation as Range clerk in one of the existing vacancies in Kurnool East Division and request that the Chief Conservator will be pleased to sanction the permanent exemption of the clerk from article 1 of the Public Service Notification with a view to his being confirmed in the vacancy.

2. I consider that it will be in the interests of Public service to sanction the exemption applied for, as Rama Rao, though unpassed is preferable to raw passed men.

3. The clerk has got a sufficient experience of Range clerk's work having put in nearly seven year's service in the Department and he is considered now to be fit for permanent employment in the lowest grade of Forest clerks. I enclose copies of the recent reports received from the District Forest Officers Bellary and Kurnool East and on the work and conduct of Rama Rao and I endorse their views from my knowledge of the clerk's work in this office. The clerk has now been working in my office from July last and I find his work on the whole satisfactory.

4. In the circumstances, I recommend the grant of his exemption as a special case, so that I may confirm him in the vacancy existing in the Kurnool East Division. An application in the prescribed form is herewith submitted.
