The Commissioner recommends that M.R.Ry.S.Nageswara Ayyar, Excise Sub Inspector, II-grade, may be exempted from passing the departmental tests prescribed for the grade.

2. According to the special tests notification approved in G.O.No.478-Revenue, dated 22-3-1924, Sub Inspectors I and II grades in the Excise Department are required to pass Test A - Criminal Law, Test C - Excise Manual, Test D - Distillery Manual and Test E in two languages. The Sub Inspector has not passed any of the tests. He was given the usual four

chances to pass them. But the Sub Inspector was not able to apply for any of the examinations on account of his sickness due to his having worked in malarial tracts. The Sub Inspector has put in 30 years' service and is aged 52 years. It will be very hard to enforce the examination rules in his case and to ask him to pass the examination at this age. The local officers therefore recommend that the Sub Inspector may be exempted from passing the departmental tests, and the Commissioner support their recommendation.
