Sir.

I have the honour to submit below a scheme for the introduction of engraving in the Municipal Art School, Kumbakonam.

2. Instruction in engraving is proposed to be given to about 20 pupils in two sections of 10 at a time, each section receiving 2½ hours of instruction per day. Many of these students have studied up to the VI form and are at present receiving instruction in Drawing, Painting and design and some of them also possess technical certificates in Drawing.
3. Mr. Porrett who scrutinised the scheme reports that engraving is a highly specialised art and that instruction in
