Sir.

I have the honour to submit below a scheme
for the introduction of manual training in wood work in
the Board High School, Kirkal under the South Kanara
District Board.

2. Instruction is proposed to be given to about 144
pupils of Forms I to III in sections of about 16 at a
time, each section receiving about 2 periods of
instruction per week.

3. Mr.Porrett who scrutinized the scheme estimates
the recurring and non-recurring charges at Rs.724 and
Rs.925 respectively as per details given in the margin

4. The District
Board has in its
resolution dated
30-5-25(copy
enclosed) stated that

1/2 the cost will be met from the sum of Rs.350 already
sanctioned by the Board for the purpose and the
balance will be made up by donations.

5. I recommend the scheme, subject to the
limitation that only 1/2 the cost is met from Provincial
funds. In other words if the donations do not come in,
the District Board funds must make up the difference.
I request that this point may be made clear in the
order sanctioning the scheme.

6. I beg to add that the scheme in question has
not been provided for in the current year's budget.
Nor is it possible for me at present to say whether
any savings will be available to meet the cost of the
scheme during the current year.

7. I shall however have the necessary provision
made in Part II of the Budget for 1926-27.

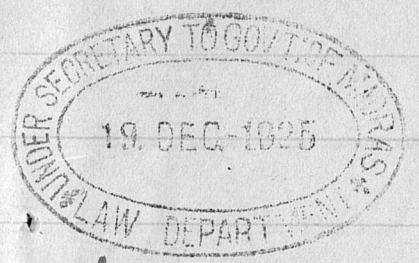
