Sir,

I have the honour to submit below a scheme for the introduction of horticulture in the Rajah's Secondary School, Nileshwar.

2. Instruction is proposed to be given to about 35 pupils of classes IV and V and forms I to III for 2 hours instruction per week.

3. The Adviser to Government on Manual and Vocational training who has scrutinised the scheme estimates the recurring and non-recurring charges at Rs 558 and Rs 774 as per details noted in the margin.

4. The management is prepared to meet half the cost (recurring and non-recurring) and requests that the other half may be sanctioned from Provincial funds.
