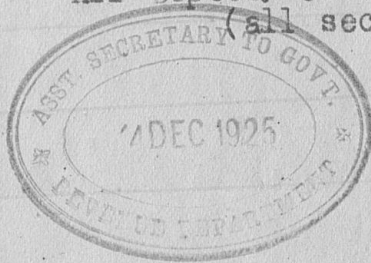
2. The A.G. is requested to hold in abeyance the recovery of over-payments in all cases until orders are passed by Government on the applications.
