In their order No. 59-Mis. This authorisation is subject to the condition that

that the payment of the special grant does not involve the foot in any increase over the amounts allotted at present or prospectively. or the general principles indicated in paragraphs 2 to 4 of G.O. 1486, Home (Edn), of 11.12.20 and paragraph 2 of G.O. 1621, Law (Edn), of 14.11.21, should be followed.
