I have the honour to submit herewith the enclosed application for grant-in-aid towards the purchase of books required for the use of the Sri Meenakshi College, Chidambaram, at an estimated cost of Rs. 17,732 only.

Excluding the cost of these books, which comes to £33-3-6 or Rs.498-0-0, calculated at Rs.15 per £, the net estimated cost of the remaining books amounts to Rs.17,732.

3. In view of the further affiliation of the College in the B.A.Pass Course in Groups ii-A, ii-B and VI and in the B.A.Honours course in Groups iii-A, iii-B and V from July 1925, I request you will be so good as to obtain the sanction of Government to the inclusion in the approved list of the application herewith submitted, rendering the institution eligible for a grant of one-half of the actual cost not exceeding Rs.8,866/-, if and when funds become available, provided that the conditions of the Grant-in-Aid Code are fully complied with.
