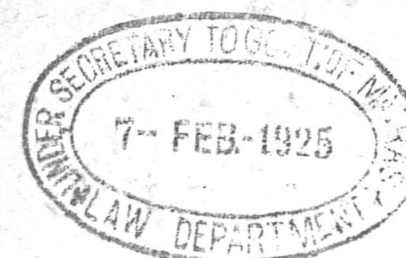

Sir.

In G.O.No. 1554, Law (Education) dated 5th November 1923, Government approved my proposal to attach a weaving class to the Panthalayani Chalia Elementary School under the Kurumbranad Taluk Board and sanctioned the payment to it of a subsidy of Rs 360/- during 1923-24.
2. The class is reported to have been opened only on 12th March 1924 and that 64 pupils (all of whom belong to the weaving community) are receiving instruction, in sections, each section receiving half a day's instruction per week.
3. The President, Taluk Board, Kurumbranad reports that since the weaving instructor joined duty on 12th March

1924 no expenditure was incurred on his account during 1923-24 .
He further states that a sum of Rs 352 in round figures was
spent during 1923-24 for weaving apparatus , thread etc.

Since half the above expenditure is to be met from Provin-
cial funds and as a subsidy of Rs 360 was paid to the Taluk
Board in 1923-24 the unspent balance of subsidy standing to
its credit on 1st April 1924 after meeting expenses of 1923-24
was Rs 184. (Rs 360-176) = Rs 184

4. As regards the expenses of the class during 1924-25

Mr.Porrett who was consulted reports that a sum of Rs 100
will be required under non-recurring for the purchase of tools
and Rs 714 under recurring charges as detailed in the margin.

5. As out of the total non-recurring grant of Rs 495, sanc-
tioned in G.O.No. 1554, Law (Education) dated 5th November 1923,
a sum of Rs 319 only was spent in 1923-24 under this head, I
consider that the amount of Rs 100 asked for under non-recurring
charges may be admitted, seeing that these two sums do not exceed
the amount originally sanctioned.

6. As regards the unspent balance standing to the credit of
the Taluk Board, the President reports that it has been adjusted
by him towards the maintenance of the school itself. But since
the subsidy of Rs 360 sanctioned in the G.O. already referred to
was for the weaving ~~the~~ class, I am of opinion that it cannot be
adjusted by the President towards the maintenance of the school
without the previous sanction of Government and that it should
therefore be adjusted towards the subsidy payable to the Taluk
Board for the weaving class during the current year.

7. I have the honour therefore to recommend that a net amount
of Rs ~~223~~ ^{*223} be paid to Taluk Board, Kurumbranad as subsidy for the
weaving class during 1924-25 after deducting the unspent balance
standing to its credit - the expenditure being met from the

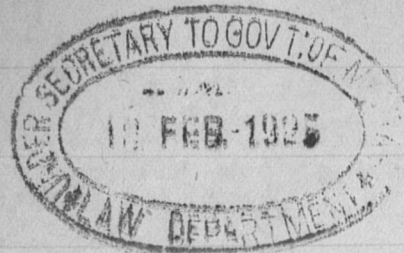
