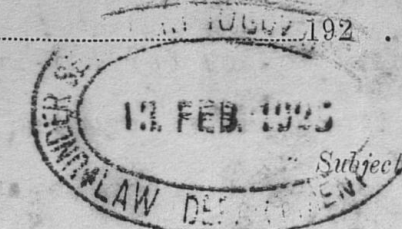

Sir,

In submitting herewith letter R.O.C.No.484.G1 dated 1-12-24, I have the honour to state that the Muhammadan Elementary School transferred to the Municipality was at the time of the transfer maintained from the funds of the Taluk Board, hence, no subsidy was payable to the Council at the time of the transfer. Further, the subsidy payable towards Elementary Education under the proviso to Section 37 of the Elementary Education Act of '20 is to be fixed with reference to the actual recurring expenditure incurred from Provincial funds in 1920-21. No provincial subsidy was paid to the Council in that year and consequently no expenditure was incurred

incurred by the Municipality from provincial funds, so that no subsidy is ^{due} ~~done~~ under the proviso.

2. The other Elementary School for Adi-Dravidas was opened out of Municipal funds and there was no promise of the payment of a subsidy. Expenditure from Municipal funds on Elementary Education is obligatory under Rule 47 of Schedule IV - Part II of the District Municipalities Act of '20. There is no deficit in the budget of the Elementary Education fund under the Council's control (Vide G.O.No. 1160 Mis., Law (Education) dated 15-7-24).

3. As suggested in para 2 of G.O.No.2645 L.&M., dated 24-9-24, the Council may be advised to consider the question of making elementary education compulsory and to this end the Council may levy an Education cess which would enable it to receive at least an equal sum from Government under Section 37.
