inconvenience and labour.

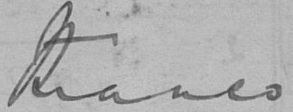
In these circumstances I request that Government may be pleased to standardise the forms in question and include it under Educational Forms Group- A Special to this office.

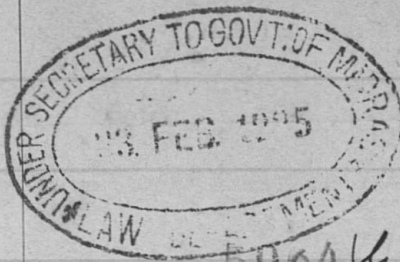
