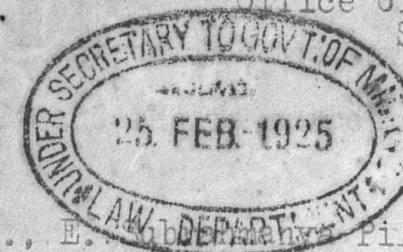

order Adverting to Government memorandum no. 276 dated 20th Feb. 25, I have the honour to state that the total amount of expenditure under the head of Travelling allowance upto 22nd instant is Rs. 580/- There was a meeting of the Council to-day and the members who attended the meeting will have to be paid their Travelling Allowance. Their bills cannot be passed for want of sufficient funds.

2. The inspection reports and the assignment of Teaching grants were dealt with by the Council to day. Some more inspection reports are due, and another meeting will have to be summoned before the close of the official year for the disposal of assignment of grants. The probable amount that may be required will be about Rs. 160/- and odd and I therefore request that you will be so good as to accord sanction for the amount.

3. I may also add ^{that} some of the Elected members have to attend the meetings from distant places and the attendance at meetings during the year was more satisfactory than in previous years.
