Sir,

In G.O.No. 1263 Law (Education) dated 8th September 1923, Government sanctioned a subsidy not exceeding Rs.12,100 or one half of the cost, towards extensions to the Board Secondary school, Tirukkoilur, to be paid after expenditure on the building is actually incurred. The President, District Board, South Arcot reports that the work has been completed and expenditure to the extent of Rs.23,535 has already been incurred. I recommend that a subsidy equal to one half of the expenditure so far incurred, Viz., Rs.11,767 may be authorized for payment to the District Board, South Arcot during the current year.

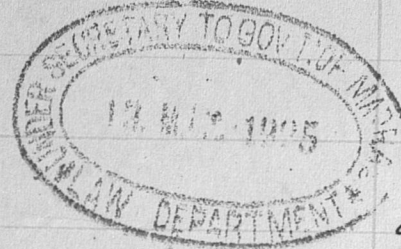
