1. The representation of the Oriental Colleges on the Senate and the Academic Council.

2. That there shall be a separate faculty for Tamil, Telugu, Malayalam and Kanarese.

3. The representatives of the chief vernaculars of the presidency shall be ex-officio members of the Academic Council and of the respective boards of studies. The University Act should be amended to make this provision.
