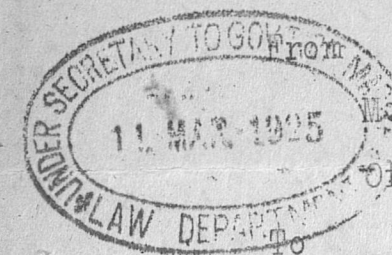

In continuation of this Department letter No.1, dated the 2nd January 1925, I am directed to say that in view of the terms of the report of the Director of Public Instruction, Madras, upon Mr. Raghava Achariyar's work during the past year, the Secretary of State in Council does not feel that a departure from the decision not to make any further appointments to the Indian Educational Service for the purposes of local Governments would be justifiable in this case. He regrets, therefore, that he is unable to act upon the recommendation of the Government of Madras for Mr. Raghava Achariyar's confirmation in that service.

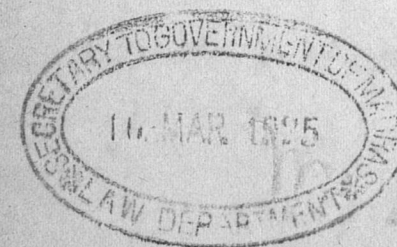
