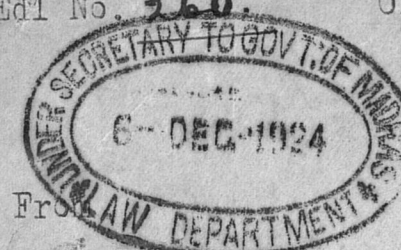

With reference to para 4 of G. O.No.1733 Mis dated 10th November last, I have the honour to state that at present the Educational Council office is located in two small rooms measuring 12 feet in length and 8 1/2 feet in breadth. There are no windows to these rooms also. They are apparently of very ancient structure, and the place is also full of white ants which attack the records some times. There is also apparently no suitable vacant public buildings for the accommodation of this office. The clerks find it very inconvenient to work, in these rooms as the sun's rays fall on them for a greater portion of the day if the doors which are the only means of light are kept open. I have absolutely no place to sit and do office work when I go over to attend meetings.

2. The Council came into existence about four years ago, and the records are increasing in volume year by year. More space will also be required for preserving these records. It is for these reasons that the Council provided a sum of Rs.120/- in the Budget for 1924-25 and I request that the Government will be pleased to sanction that amount.

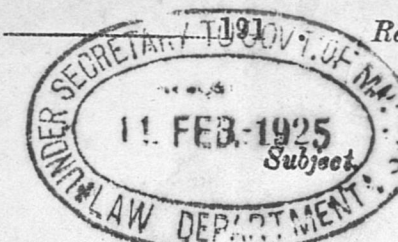

The general principle of avoiding expenditure on rent charges for the accommodation of District Educational Councils ^{offices} has been departed from in a few cases. In the case of the District Educational Councils of Egmutur, Eranjan and Kurnool, permission has been granted to incur rent charges up to Rs 5, 15 and 5 respectively per mensem. The President, D.E.C., Salem now requests sanction for payment of a monthly rent of Rs 10/-. The Collector of Salem, to whom a reference was made, has reported that there is no other suitable public building at Salem for the accommodation of the office of the D.E.C. Submitted for orders whether the President's request may be agreed to. Attention is solicited to the note of the D.P.I. submitting the budget estimate of the D.E.C., Salem, for 1924-25, where he has recommended the provision of Rs 120/- for house-rent.

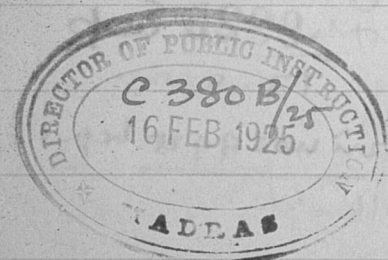
