The Commissioner requests that Government may be pleased to sanction the permanent exemption of Mr. Abdul Razak - IV grade Sub-Inspector. Mr. Abdur Razak was exempted temporarily in 1920 by the Board for appointment as Sub-Inspector in acting Sub-Pro-Tem and Temporary vacancies. He was confirmed as a Sub-Inspector in August 1922. As he was through out working in the Agency and as Article 1 of Public Services Notification is inoperative in the Agency tracts, his permanent exemption was not considered at the time of confirmation. It is now proposed to transfer him from the Agency to the Plains. Unless he is permanently exempted, his confirmation cannot
